**STORAGE**

**STORAGE OF EXPORT CARGO FOR LEGAL ENTITY**

- **For general, dangerous, valuable cargoes and cargoes requiring special security measures** – payment for the first four days of storage, excluding the day for acceptance the cargo to the warehouse, is included to the ground handling rates. Further the payment for storage is charged according to the rates of the actual Price-List;
- **For the cargo with temperature requirements** – the payment for storage is charged from the next day after acceptance the cargo to the warehouse according to the Price-List for this category of cargo.

**STORAGE OF IMPORT CARGO FOR LEGAL ENTITY**

- **For general, valuable, dangerous cargoes and cargoes requiring special security measures** – payment for the first two days of storage, excluding the day for sending to the consignee a notification about the cargo arrival, and also days-off following immediately after the day, when the notification is sent, is included to the ground handling rates. Further the payment for storage is charged according to the rates of the actual Price-List;
- **For the cargo with temperature requirements** – the payment for storage is charged from the next day after the day of notification the consignee about the cargo arrival, according to the Price-List for this category of cargo.

*Note:*

- *When calculating the storage time, the term "day" means a period of time ending at 24 hours and 00 minutes of the current calendar date. The payment is charged for full days regardless of the time when the notification is sent to the consignee and the time, when the consignee receives the cargo during the paid day;*
- *If notification about temperature cargo arrival is sent to the consignee (a legal entity), later then 18-00, the day of notification shall be considered the*

<p><i>next calendar day;</i></p> <ul style="list-style-type: none"> <li>• If the cargo arrives partly, the storage of the cargo starts from the first part of the shipment arrival and calculated for each of the shipment separately;</li> <li>• If there are several kinds of cargo in one airwaybill, the storage charge at the more higher rate;</li> <li>• Sheremetyevo-Cargo JSC can determine individually the specifics of calculating the storage period falling on non-working holidays and postponed weekends for the purposes of storage payment.</li> </ul>
